- · Refreshing professional training products

- Considering the challenge of European legislation coming back to the UK following the UK decision to leave the EU.
- Air pollution levels in cities causing concern and presenting challenges for the profession
- Looking at the issue of mental health as part of the public health challenge

South Africa - Selva Mudaly

- Undergoing changes in operation of the Professional body

- Quantifying the cost of providing an Environmental Health Service at local and provincial level

11. Finance - (Hon Treas)

1. Annual Report & Financial Statement for year ended 31st December 2016

The Hon Treasurer presented the accounts for the year to 31st December 2016 and asked the meeting to approve the formal accounts.

The meeting noted Steve's report and unanimously approved the Financial Statement for formal approval at tomorrow's AGM.

2. Budget for 2018 - Report by Hon Treasurer

The Hon Treasurer presented the budget for 2018 taking account of anticipated expenditure.

He highlighted specific budget lines in relation expenditure covering meeting costs and Regional Group funding. The meeting asked that the funding applied to each Region be separately listed for clarity.

The meeting unanimously approved the budget.

3. Membership Fees 2018

The Hon Treasurer informed the meeting that because of the low levels of inflation he recommended a small increase of 2% of the current fee level.

Following discussion and further clarification from the Hon Treasurer the meeting agreed to this proposal.

4. Sponsorship, Hedgerow Bursary, Roy Emerson Award, Eric Foskett Award

The Hon Treasurer presented the following to the meeting:

Hedgerow Bursary £4,100

Present at this meeting will be sponsored Council representatives from Uganda, Malawi, South Africa, Nigeria and Trinidad & Tobago. It would not be possible for these colleagues to attend without this support. Their attendance benefits the Council meeting by increasing worldwide membership participation in IFEH affairs. This Bursary is sponsored by Hedgerow Software Ltd.

Roy Emerson Award £1,500

This award is in memory of Roy Emerson, the first President of IFEH and is for an undergraduate student from one of our Academic Associate Universities or a University in a Member country. The Award is sponsored by Highfield ABC and RIAMS. The competition is based around an essay topic set by the Board and assessed by a Board panel. The prize is the opportunity to present the winning paper at the IFEH International Academic and Research Conference with all expenses paid from the sponsorship.

Eric Foskett Award - £1,000

Many members of Council will remember Eric Foskett as the first Secretary of IFEH and the developer of the initial concept of an international association of environmental health professional bodies. The award is given to an individual or organisation who has given outstanding service to the organisation and it is awarded at each World Congress. The award is sponsored by the Chartered Institute of Environmental Health.

12. Policy Matters

1. Data Protection Act - (Hon Sec)

The Hon Secretary referred to the report that he had previously circulated and highlighted the following points:

- Following the initial e mail Hoax he had immediately warned members of the scam and not to respond to the e mails. Despite this warning one member passed over money in the good intention of helping a fellow member.
- Within 24 hours all communication is now by using the BCC window to minimise risk, this action is also being applied to all Board and Regional Group correspondence.
- Since the initial hoax there have been several more of similar nature and the Hon Secretary has issued warnings immediately on these coming to his attention.
- Tim Everett and Henning Hansen are working with the The Hon Secretary and the Hon Treasurer to ensure compliance with the DPA and developing process to minimise any future risk.

Following questions and comment the meeting noted that a full report will be submitted to the Council Meeting in Auckland for consideration and approval.

Action: The Hon Secretary to produce a report for the Council Meeting in Auckland

13. Hedgerow Bursary - Report on Amendments and Update to Bursary Conditions - (Hon Sec)

The Hon Secretary referred to the Report that he had previously circulated and highlighted the following points:

- Priority is to be given to the countries in the lower bands of the World Bank Listing.
- The paragraph relating to other eligible categories had been deleted
- The paragraph relating to applications being considered on a "first come first basis" has been amended to take account of the lower income countries being given preference.

Following discussion the meeting approved the amendments and agreed to the Hon Secretary amending the Procedures Manual accordingly.

Action: The Hon Secretary to update the Procedures Manual accordingly.

14. Roy Emerson Award - (Hon Sec & Hon Treas)

The Hon Secretary referred to the Report that he had previously circulated and highlighted the following points:

- 18 entries were received
- The Evaluation Panel was Chaired by our President, Peter Archer and he advised that the quality of the entries was excellent.
- The winner is present at the Academic Conference and Members were requested to ensure the attended the session and supported the presentation.

15. Activities & Projects

1. IFEH Sponsored Project Malawi 2016 - (Hon Treas)

The Hon Treasurer referred to his report that he had been previously circulated and highlighted the following points:

- The Federation had previously agreed to support the water and sanitation project at Chigolo Primary school in the Salima district of Malawi.
- An appeal to Federation members raised the sum of £2,437 and the balance of £3,050 is being paid from IFEH Reserves,
- The donations from members were REHIS £1,500, EHAI £660 and SAIEH £277
- The Malawi Environmental Health Association are managing the project on behalf of the Federation.

The meeting noted the report and thanked the three member associations for their generous support. As a result of this report the meeting thought it may be appropriate to support a similar project in Jamaica. It was agreed that colleagues from Jamaica should bring forward a project for future evaluation by the Federation.

2. IFEH Partnership with the UNISDR on Disaster Risk Reduction - (Henning Hansen, Hon VP)

Henning referred to his detailed report which was previously circulated to members and informed the meeting that we are now closely co-operating with the UN office and have partnership working. As a result of this partnership we are now being invited to UN sponsored activities related to Disaster Risk Management (DRM).

In addition the following matters were noted:

- The Meeting supports the formal partnership which runs for a 4 year term
- Henning leads the IFEH DRR Committee which reports to the IFEH Board. Members of the Group include Peter Archer, Steve Cooper, Jerry Chaka, Peter Davey, David Dyjack and Tim Hatch
- Any future actions which may have a financial implication will require Board approval prior to any action
- The DRR Committee has up to 3 representatives from the IFEH Regions and can have representation and the Faculty Forum
- Where appropriate, set up Regional Group DRR Committees
- The DRR Committee will develop work programmes with the primary focus on sharing knowledge and information
- The DRR Committee aims to develop a work programmes to strengthen participation and include more members from the academic and scientific community

Henning asked the meeting for approval in principle for his proposals.

Following discussion and clarification the meeting made the following comments:

- Henning was thanked for his energy and drive in taking this matter forward
- The meeting agreed that Henning should continue to lead the DRR Committee
- The meeting was of the view that the proposed Committee representation was too large and that the Committee should, if possible, be no more than 12 members
- The committee should draw on the expertise of Environmental Health Practitioners within the Federation

In conclusion the meeting thanked Henning for his work and approved the proposal in principle with the caveat that Henning with his Committee refines his definitive proposals in light of the comments of the meeting.

16. Communications & Public Relations

1. Website - Update from Webmaster

Henning informed the meeting of the following matters:

- Website IT security will be taken care of as quickly as possible, there may be a slight cost.
- Wide range of SIGs now available moderated and chaired by Henning, selective in that only members or members of national organisations can join.
- WEH day lots of information on the site, some events posted from countries who are not IFEH members.

2. IFEH Journal - Update from Editor

The meeting noted that the Journal was now in publication again but there was no update available to the meeting. Members are asked to support the editor with new papers for future publication.

3. Newsletter - Update from Editor

The meeting noted that the newsletter is being issued on a regular basis but there was no update available to the meeting. Members were asked to support the editor with new short articles for future publication.

The meeting thanked the Webmaster and both editors for there valued work on behalf of the Federation.

17. World Environmental Health Day 2017 - Indoor & Outdoor Air Quality'

The Hon Secretary informed the meeting that support for WEHD had again generated interest from members in all regions of the Federation however this interest was not uniform across all of the Federation Regions.

Henning Hansen informed the meeting that all the projects and celebrations for WEHD are posted on the WEHD page of the Federation Website.

18. World Congress & Academic Conferences - Updates

1. 2018 - 15th World Congress - Update from Stephen Bell NZIEH

Stephen was unable to attend the meeting but it was noted that arrangements are in now in place and members can now register for the congress and make the necessary accommodation arrangements.

2. 2019 - 3rd World Academic Conference

David Musoke informed the meeting that would be delighted if the meeting would agree to Makerere University, Uganda hosting the Council Meeting/AGM and 3rd Academic Conference. He proposed that the Meetings and Conference would take place on April 2019.

The meeting was delighted to accept this offer and looked forward to meeting with Ugandan colleagues in 2019.

David will now liaise with the Hon Secretary and Hon Treasurer to make the necessary arrangements.

Action: The Hon Secretary to officially inform David Musoke that the offer was approved and accepted.

3. 2020 - 16th World Congress - Submission of Bid from TEE Eng Ong MEAH

Due to unfortunate absence of TEE at the meeting the Hon Secretary referred to the Submission which had been previously circulated. He further advised that the bid had been evaluated by the Board in advance of the Council Meeting and that the bid from Malaysia was the sole bid which was received following a call for bids from all Member Associations.

The meeting agreed that this was an excellent bid which was thorough and covered all areas for a successful Congress.

In conclusion the meeting unanimously approved the Bid from Malaysia to hold the IFEH World Congress in Malaysia in 2020.

Action: Hon Secretary to officially inform the Malaysian Association that the Bid was approved and accepted.
