National President's Report cont.

On 26 September we will celebrate 'World Environmental Health (WEH) Day'. WEH Day is an important international day inaugurated in Bali in 2011. This special event is to be held on 26 September every year across the planet in perpetuity. As we approach WEH Day 2012, I ask members to visit the International Federation of Environmental Health website (www.ifeh.org) to view the declaration and to listen to the song written and performed by the Indonesian EH Students. These students formed their professional student association in Bali in September 2011 where the WEH Day declaration was made. It is quite inspiring and the challenge is on for our talented Australian EH students to come up with a either a song or a message that they think will suit such a special day. The EHA National Directors plan to have a themed announcement that will reflect the importance of this event. I encourage you to keep in touch with our NEO, Victoria Mokhami, with your ideas so we can put this day firmly on the calendar every year from now on.

A further recent international action out of the international conference in Vilnius, Lithuania, in May 2012 was for each national organisation, EHA in our case, to get involved to whatever degree possible for contributing to the WHO 2008 Commission report "Achieving Health Equality Through Action on Social Determinants of Health". The paper summarises the particular health inequalities and sets out three principled actions for improvement which will hopefully remove inequalities within one generation across the planet. IFEH collated all member associations (i.e. EHA) feedback on the report. EHA noted the following areas for improvement.

- Obesity should be included in the areas of concern:
- There is no mention of economic health and its relationship to public health; and
- There is no reference to the availability of water and food.

Back on the home front, EHA has been invited to attend meetings of the Commonwealth Industry Reference Group (IRG) for the Community Sector Development Streamline and Review with particular reference to Indigenous Environmental Health Workers. EHA hopes to influence this review where it suits the needs of IEHW practitioners.

Finally, as members of EHA, I ask that you keep in touch with your State Association and your National Directors at every opportunity as many of you have been doing. This will assist EHA to better provide for members' needs and enable EHA to continue to meet members' needs.

National Treasurer's Report

I am very pleased to report that the National organisation Environmental Health Australia Ltd, has finished the year with a reasonable surplus. Although the surplus is lower than the previous year, there have been quite a number of projects commenced, whereas in the prior year no monies were spent on the projects due to the internal constraints applied during the transition period.

The National Board of Directors has been strengthened and we have met as a full group for the first time in several years. This is important as under the new structure the need for consensus is able to be more easily met, and the spending on projects more appropriately apportioned. That is to say, we don't need to accumulate as much money, to get well considered projects rolled out in a timely manner.

We have now appointed a new National Executive Officer (Victoria Mohkami) who has commenced working for the organisation based out of the offices in Queensland. We all welcome Victoria into the organisation where her accountancy skills and training will be well received. We have updated the computer systems and work on software compliance is a continuing task.

There are a number of other projects which will require funding during the coming year. This includes the new website project, CPE/CPD for EHOs, the Universities accreditation project (on-going with Commonwealth Funding – thanks to Bruce Morton for leading this project), and others.

As part of the preparation for a properly constructed budget for the coming year (including a three year fiscal plan), we are also reconsidering the so called "affiliation agreement" which had been put together some four years ago and was administered out of the former State branch in Melbourne. On initial analysis the requirements seem somewhat draconian so a number of new models are being considered and tested, including an excellent proposition from South Australian members (thanks to Susan, Mina and Angela).

We are now on track for an excellent 2013. As soon as audited figures are available we will put them up (in draft form) onto the website. We are looking forward to our annual general meeting at the National Conference in November on the Gold Coast. We hope to see as many members as possible at the conference (this will help the finances as well for both National and Queensland). Please do not hesitate to ask any questions on our new structure or finances and we will do our best to answer in a timely and accurate way.

Strategic Direction to Drive Member Services

With the organisational changes for Environmental Health Australia (EHA) finalised, the Board has taken the opportunity, to refocus efforts on member services and the restructuring of national activities to provide the most efficient support to member Associations in the States. A priority task has been Board input and agreement to the strategic directions for the EHA National organisation to achieve the best outcomes for the Associations and for Environmental Health. The national Board has sought feedback on the draft strategic plan from the State Associations. The plan sets the Vision, Mission, Corporate Goals and Key Result Areas for the national organisation and establishes values for the Environmental Health Profession. The values of professionalism, integrity and ethics, transparency, accountability, responsiveness, and sustainability and stewardship will be enunciated in the organization's code of conduct which member associations are expected to adhere to.

Individual values will be the subject of focus for coming newsletters and we'll be seeking input from Members that can demonstrate "living the values" within the Environmental Health Profession.

The core components of the strategic plan include the following.

Vision

Environmental Health Australia aspires to enhance the practice of Environmental Health to provide a healthy, safe and attractive natural, built and social environment for all of the communities of Australia.

Mission Statement

Environmental Health Australia is the premier environmental health professional organisation in Australia. Environmental Health Australia will continue to develop and maintain a quality environmental health workforce and advocate for enhanced environmental health standards for, and on behalf, of all the communities of Australia.

The EHA National organisation will continue its work to achieve its mission focusing on three (3) broad strategies or key result areas:

- Organisational the continued improvement of organisational capacity focused on improving sustainability and resources.
- Professional practice the enhancement of professional environmental health practice through development of standards of practice, professional development and certification/accreditation schemes.
- Environmental health advocacy the enhancement of environmental health advocacy through the development of environmental health policy positions, policy networks and relationships, and advocacy mechanisms.

Refocusing Environmental Health Australia

The Environmental Health Australia (EHA) Board of Directors met in Adelaide in mid-June. With the State Presidents from South Australia (Susan Bennett) and Queensland (Belinda Davies) and Executive Officers Mina Labaz (SA), Margaret Hind (Qld, NSW, Tas) and Julianne Samandari (WA - via teleconference) the Directors worked over two (2) days to reset the national agenda. The aim of the meeting was to establish the organisational and strategic directions for the national body, to represent the interests of all State Associations and the environmental health profession across Australia.

The key outcomes from the meeting have been:

- The re-drafting of the organisational strategic plan for the period 2012-15 to reinvigorate the organization and adjust to the federated structure;
- The review of submissions from organisations to reinvigorate the EHA website to improve member services;
- The finalisation of the environmental health university course accreditation review, including a proposal to conduct two (2) workshops in Brisbane and Adelaide to gain cross stakeholder engagement, and a University focus group with selected universities to test and provide feedback;
- Finalisation of the appointment of a National Executive Officer to assist in the day-to-day operations of the national body and the implementation of the national projects and programmes;
- The revision of national financial arrangements including the ongoing review and implementation of the service agreement with the State Associations to ensure that State contributions to the National body are equitable and manageable whilst retaining the viability of a national focus;
- The establishment of protocols on a variety of issues for the continued operation of a truly national representative body for the environmental health profession with invigorated and autonomous State Associations;
- The review and re-establishment of former national programmes including the Continuing Professional Development (CPD) and Certified Environmental Health Practitioner (CEHP) Schemes and the peer review journal;
- Update and final arrangements for the 37th National Conference and workshop programme being conducted by EHA Queensland and Gold Coast City Council to be held at the Hilton Surfers Paradise 11th – 16th November 2012; and
- The appointment of Susan Bennett and Angela Sorger to the Board as representatives from the South Australian Association. The Board now has representation from every State with the exception of Victoria.

University Accreditation

EHA has a national accreditation system for universities that want to be recognised to graduate environmental health officers (EHOs). Currently 12 universities across Australia have courses accredited with EHA which include undergraduate and postgraduate qualifications.

The primary objective of all accreditation program is to promote courses that equip graduates with the required skills, knowledge and attributes to enter the profession. Programs state a commitment to supporting academic institutions to consistently meet professional requirements and benchmarks and thereby assure a high standard of professional practice. For over 25 years EHA has been the national tertiary Environmental Health course accreditation body and its accreditation scheme is recognised by State jurisdictions and through enHealth. Our Health University Course Accreditation Policy was reviewed and updated in 2011 which is the current benchmark for universities to meet.

The process for accreditation is described in the Policy and requires a university to make an application to EHA and demonstrate how the university will meet the EHA Policy. Then an accreditation panel is formed by the Course Accreditation Chair and includes an environmental health course academic, State and Local Government representatives and a representative of the Western Australia EHO Professional Review Board. Our partnership with the WA EHO Professional Review Board is to match our respective processes and combine resources to ensure qualifications to practice as an EHO are recognised by both organisations.

EHA has recently added 2 new universities to the accredited family with Central Queensland University (CQU) and University of the Sunshine Coast (USC) receiving their accreditation certificate. Further, Edith Cowan University received accreditation in early 2012 for a new 3 year environmental health course. This university changed their previously accredited 4 year degree. A number of reaccreditations are in the system and the University of Tasmania recently submitted an application for reaccreditation with EHA. Our accreditation system is valued as EHA continues to field questions from other universities seeking advice about accreditation and what benchmark they have to meet to receive accreditation.

Many government and even private employers mandate that a prospective employee must hold a qualification from a university that is accredited/recognised by EHA. For example, to be employed by Queensland Health as an Environmental Health Officer the person must possess a degree accredited/recognised by Environmental Health Australia. This requirement is cemented in Industrial Relations law through the Enterprise Bargaining Agreement for Health Practitioners. It specifically states that an 'applicant must hold a tertiary degree (or equivalent) qualification that is accredited by Environmental Health Australia.' Therefore, if a person doesn't hold an EHA recognised qualification, they cannot work with Queensland Health as an EHO. Further our national accreditation system is accepted internationally through the International Federation of Environmental Health (IFEH).

There is significant choice for prospective students and cadets with on-campus and external learning as well as undergraduate and postgraduate courses across Australia. Obviously the accredited courses also provides students with quality skills for other employment opportunities with a variety of government agencies or private industry.

EHA/enHealth University Course Accreditation Project

As reported in the previous national newsletter, EHA is managing an \$80 000 project with enHealth regarding University EHO Course Accreditation that will inform EHA's Environmental Health Course Accreditation Policy to ensure it remains contemporary and embraces the EHO Skills and Knowledge Matrix released by enHealth.

The project steering group has met a number of times to receive updates from the consultant (Kim Windsor) and two stakeholder workshops have been held in Brisbane on the 22 June 2012 and in Adelaide on the 27 July 2012. The workshop was attended by representatives from EHA, State jurisdictions, universities, local governments and private employers of EHOs. The workshop allowed direct engagement with industry representatives and allowed the participants to go through the project working paper to raise issues and provide feedback to the consultant to inform the project outcomes.

National Broadband Network (NBN) Submission

The Australian Government announced a funding opportunity in conjunction with the National Broadband Network (NBN). The funding is to be used for projects that stimulate the development of education, training or skills services designed to take advantage of high-speed broadband connectivity, available through the NBN. The funding was restricted to a range of applicants which included professional associations.

Through its members, EHA saw a great opportunity to take the leading role in the development of nationally consistent environmental health tools that develop education, training and skill services using the NBN.

The EHA national board approved to submit a funding submission of over \$900 000 for the NBN funding to develop an online food safety assessment tool for use by Environmental Health Officers and an online food safety self-assessment tool for use by Food Business Operators and staff. The operator's assessment tool would reflect the assessment tool used by officers and allows a food business operator to conduct their own (voluntary) food safety assessments to determine their own compliance any time and as often as they like.

The outcome of the funding submission is expected within the month and hopefully we can soon report back to all EHA members the success of the funding submission and details of the agreement between the Australian Government and EHA. Thank you to those local governments and State jurisdictions that provided letters of support for the funding submission.

President's report - Belinda Davies

2012 is proving to be a challenging year for environmental health professionals in Queensland. After the State election the Newman government discontinued the employment of most temporary employees, contractors and consultants including several EHOs. The State government is about to announce which additional 15,000 State employees will be made redundant. It is inevitable that this will affect more EHOs — both the ones made redundant and those left coping with excessive workloads. Consequently one of the most important roles EHA Qld has played this year has been one of advocacy. We have written to various government representatives advocating for our members and the broader environmental health workforce, explaining the important role we play and the excellent track record we have.

On a brighter note, we are very fortunate to have a large and committed board who voluntarily take the lead on various projects/programs. Earlier in the year the Qld Board updated our business plan and in a recent face-to-face meeting we started developing some policy statements. Drafts will be made available to members for comment before finalisation and distribution to relevant stakeholders.

EHA Qld continues to partner with the Local Government Association of Queensland (LGAQ) and other stakeholders regarding workforce issues. Recently EHA Qld, LGAQ and Griffith University partnered to develop an EHO workforce modelling tool. The tool will be used by local governments to identify the number of FTE EHOs required to complete the local environmental health workload. The tool also provides an indication of future EHO needs based on projected population growth.

All of the Queensland regional groups are active. We are grateful to have such enthusiastic and committed members leading the regional groups, ensuring successful local events for environmental health professionals.

Over the past few years the EHA (Qld) Inc. board has developed an extensive professional development program. Several new courses have been developed based on member feedback and where possible training has been delivered in regional areas. All workshops and courses are highly regarded and well attended. We're currently looking into a few workshops for 2013.

The national conference program is absolutely outstanding. The choice to attend is easy; the hard part will be choosing which concurrent sessions to attend because they all sound interesting. See you there!

Executive Officer's report - Margaret Hind

Membership of EHA (QLD) INC has grown considerably over the past twelve months with a 13% increase in financial members and a 20% increase in student members.

NSW ANNUAL STATE CONFERENCE 2012 "Environmental Health - Better Together"

This brings our current numbers up to a total of 8 Board members who are interested and motivated to build further on the momentum and direction we have created for the EH profession in Tasmania.

The Board recently held a strategic planning workshop in Campbell Town to develop a Strategic and Business Action Plan for 2012 – 2013. The Plan identifies a number of strategies and actions across areas that will positively impact on membership and the EH profession generally. The Plan will soon be released to the membership following final sign off by the Board.

To date, in 2012, the Board has organised and conducted professional development seminars in March and June at The Grange Function Centre, Campbell Town. 
