Natrum Update – Return of Unwanted Medicines

What is Return of Unwanted Medicines?

Established in 1998 and funded by the Commonwealth Government, Return Unwanted Medicines (or The RUM Project) is a national, not-for-profit company that provides consumers with a free and convenient way to safely dispose of expired and unwanted medicines. Anyone can return their household medicines to any community pharmacy. The returned medicines are put in a secure bin and then collected and disposed of by high temperature incineration in accordance with regulatory and EPA requirements.

What types of medicines can be returned to pharmacy?

Prescription medicines, over-the-counter medicines, herbal or complementary supplements, gels, liquids, creams and veterinary medicines can be returned to community pharmacy to be disposed of in the RUM bin.

Empty inhalers are safely disposed of in your normal rubbish collection but any inhaler that still contains some of the active ingredient, should be taken to the pharmacy to be put in the RUM bin.

Sharps or needles cannot be put in RUM bins. Talk to your pharmacist about the appropriate way to dispose of these items.

What are 'unwanted medicines'?

Unwanted medicines are medicines purchased and no longer needed, or medicines the doctor prescribed for a health condition that is no longer present. It is dangerous to assume that previously used medicines are suitable for new ailments. You should always consult a pharmacist or doctor before taking medicines prescribed for another condition. Medicines that are no longer of immediate use should be returned to pharmacy for safe disposal.

Unwanted medicines also include out-of-date medicines which can also be potentially dangerous. Chemical changes to some medicines after their use-by-date can cause them to lose effectiveness or can even be harmful to take. Medicines with expired dates should be returned to pharmacy for safe disposal

What is the disposal process?

Returned medicines are disposed of by high temperature incineration. The Environmental Protection Authority (EPA) has approved this process. Last year, RUM collected and safely disposed of over 700 tonnes of medicines, potentially preventing them ending up in waterways and landfill.

Why can't expired or unwanted medicines be used for overseas aid?

Medicine donations to developing countries or in disaster situations is often viewed by communities in developed countries such as Australia - as a useful way to provide much needed pharmaceutical supplies. Unfortunately, not all medicine donations are helpful and inappropriate medicine donations can be dangerous or useless, and a source of problems for the recipient countries.

The 'Australian Guidelines for drug donations to developing countries' - which are based on the World Health Organisation (WHO) Guidelines for medicine donations – states that donations should be based on an expressed need and should not be sent without written request from a competent authority in the recipient country.

Natrum Update – Return of Unwanted Medicines

Why is it necessary to collect and safely dispose of expired and unwanted medicines?

Evidence over many years confirms that medicines stored in the home can be the source of accidental poisonings of children or pets, and the source of confusion with elderly people. The National Poisons Information Centres report that over 5,000 children end up in hospital due to accidental medicine poisonings each year.

Elderly people who take multiple medicines for multiple conditions can sometimes become confused as to what to take, and the risk of mix-ups increases if medicines that are no longer needed or expired are not discarded.

Additionally, medicines and chemicals in general can contaminate the environment when discarded via landfill sites and sewerage facilities. The collection and disposal of unwanted medicines is consistent with the "Quality use of Medicines" philosophy included in Australia's National Medicinal Drug Policy.

Why can expired medicines be harmful?

The expiry date is the last day that the manufacturer guarantees the full potency and safety of a medicine. Expired medicines may be less effective or hazardous due to a change in chemical composition or a decrease in strength. Stick to the rule that if your medicine has expired, don't use it – it's not worth the risk – and return it to pharmacy for safe disposal.

How do you find the expiry date on medicines?

Expiry dates exist on most medicine packaging, including prescription, over-the-counter and herbal / complementary supplements. Sometimes expiry dates may be located underneath labels, on the lid of bottles, or at the end of cream tubes. If you can't find the expiry date, ask your pharmacist to help.

Where is the best place to keep medicines in the home?

Contrary to popular belief, the bathroom medicine cabinet is not ideal placed to store medications due to heat and humidity. Nor is the kitchen cupboard, above or next to the cooktop. Medicines are best stored in dry, cool spaces away from light, and of course out of reach of children and pets.

Country of origin food labelling

Mandatory reforms for country of origin food labelling come into effect on 1 July 2018 following on from the transition period that commenced on 1 July 2016. Guidance on the new origin labelling rules can be obtained from ACCC publication - Country of Origin food labelling. This guide will help assist businesses to comply with the mandatory reforms and assist them in identifying what they need to do to comply with the Standards.

To assist in the creation of new labels, the ACCC has released an interactive online tool which is available at the Country of Origin Labelling online tool (CoOL tool) webpage on the business.gov.au website. The tool will assist manufacturers to determine if they need a label and how to customise and download the appropriate label for their food product.



EHA Twinning Program

Nancy Bird of Logan City Council provided our 42nd EHA National Conference delegates with an update on the EHA Twinning Program with Zambia in July 2017.




EHA National Activities

EHA National Activities

Australian Food Safety Week 11-18 November 2017 - 'Is it done yet? Use a thermometer for great food, cooked safely every time'

The Food Safety Information Council drove this national wide promotion with the purpose of reducing the estimated 4.1 million cases of food poisoning in Australian annually. The FSIC prepared promotional resources, available for free, for download from their website and are encouraged participation from government and community groups nationwide.

EHA nationally provided positive press messages surrounding food safety and maintaining correct temperature controls for perishable items across all steps of food preparation, food receiving and handling, 2 hour 4 hour, cook chill, danger zones and storage.

Global Fire, Cyclone & Flood Disaster Management Forum

EHA partnered with Clariden Global for the Fire, Cyclone & Flood Disaster Management Forum which was held at Novatel Brisbane 29-30 November 2017.

The forum presented sessions with a focus on preparedness, prevention, response and recovery. The major topics covered were using technology and data to predict changes in outcomes, use of drones in disaster response, emergency management communications, response leadership, psycho-social implications of a disaster, risk assessment systems and recovery.

Reappointment of councils under Food Act 2003

In September 2016, the NSW Audit Office published a report recommending improvements to the Food Regulation Partnership, including better clarification of roles and responsibilities between the Food Authority, councils and other enforcement agencies. Councils' role in regulating retail food businesses has been refreshed and will take effect in 1 July 2018.

Many of the issues we have addressed are important to EHOs, for example the need to maintain competencies and certainty around regulating emerging trends such as home based businesses and market stalls.

Food Authority consulted extensively and met with over half of councils and highly values the feedback received. Environmental Health Australia was also consulted through the Food Regulation Forum: a statutory committee that guides and advises the Food Regulation Partnership between NSW Food Authority and councils. The app aims to 1) raise awareness amongst the community about asbestos in the home, and 2) collect data from consenting users that can inform us about the amount and condition of *in situ* asbestos in the WA residential environment. ACM Check was released earlier this year and is available for free from the App Store and Google Play.

Essentially, ACM Check guides users through a visual inspection of the inside and outside of their home and identifies potential asbestos-containing materials. Areas such as the walls, ceilings, eaves, electrical metre box, fence and outbuildings are inspected. ACM Check shows plenty of photos to help users complete the inspection, which can take anywhere from a few minutes up to 15 minutes (depending on the property). At the completion of each inspection the app generates a summary report for your home (example attached) and provides a series of recommendations about how to manage these materials.

Additionally, users can participate in the research by anonymously sharing their inspection results, which will help to map the type, amount, and condition of asbestoscontaining materials currently found in or around the home. Matt needs as many Western Australians to complete the app as possible. It would be great if you could share the app and research with all EHOs who could use it in the field or share it with their local community. South Australia Update

The Unusual Pink Creek

Beginning in 2009, Adelaide Hills Council EHO's began receiving complaints about a creek within the water catchment periodically turning pink and smelling foul. Investigations; which involved following the creek for its length, investigating all stormwater drains and even a public appeal involving a letterbox drop to hundreds of surrounding residents proved fruitless. No doubt, in part due to the extensive stormwater system in the area.

These periodic episodes continued on an off for a number of years with samples showing a high organic matter content but nothing toxic or alarming. This was until 2016 when the Mount Lofty Ranges Project Officer, while on a routine inspection of wastewater systems, discovered a non-compliant non-approved system connected to a food business.

The septic tank was uncovered and the lid was found to be in a state of disrepair with oil and grease oozing out of a hole in the lid. There appeared to be nowhere on the site to dispose of any effluent as the site had been overdeveloped.

Interestingly, there was a large shed next to the septic tank containing a cool room with several boxes of beetroot. Also located inside the shed was a soakage pit, which when examined was full of a pink substance. The soakage pit contained a pump and a hose leading to the stormwater drain.

The stormwater drains were checked and were full of pink effluent. The soakage pit was installed illegally by the owner when the shed was built over an already failing soakage trench. When the soakage trench was full the overflow was connected to the soakage pit which subsequently pumped into the stormwater drain. Council is now assessing an application to install a new holding tank system for this premises.

Needless to say, it has been rewarding to finally solve the case of the unusual Pink Creek.

Victoria Update

Ban on smoking in outdoor dining areas and regulation of e-cigarettes and shisha tobacco

Reforms commencing on 1 August 2017 to the *Tobacco Amendment Act 2016* amended the *Tobacco Act 1987* to ban smoking in outdoor dining areas and regulate ecigarettes and shisha tobacco in the same way as other tobacco products.

Legislation governing tobacco products and smoking continues to contribute to the decline of smoking rates in Victoria, and to a growing awareness of the harm associated with smoking and second-hand smoke.

These new reforms have strong community support and will contribute to reducing smoking rates and tobacco-related harm.

Epidemic thunderstorm asthma forecasting system

Grass pollen season (1 October to 31 December) brings a seasonal increase in asthma and hay fever. It also brings the chance of epidemic thunderstorm asthma.

An epidemic thunderstorm asthma (ETSA) event is an uncommon phenomenon where a large number of people experience asthma over a short period of time. The department has been working with the Bureau of Meteorology and a number of partner organisations to develop the Victorian epidemic thunderstorm asthma forecasting system.

The forecasting system has been designed to forecast the risk of epidemic thunderstorm asthma events. It is not designed to forecast the seasonal increase in asthma and hay fever symptoms which occur every year during the grass pollen season, which can be triggered by pollen and changes in weather generally.

The forecasting system serves two purposes:

- to enable health and emergency service systems to be suitably prepared on days of increased risk
- to raise community awareness of possible events so, where possible, those at increased risk can
 - avoid exposure to the storm, especially the wind gusts that precede them (ie go indoors with windows and doors closed and air conditioner on recirculate if in use)
 - have their reliever medications appropriately available and
 - have a chance to revise their asthma management plan or asthma first aid

Environmental Health Australia (Victoria) Limited AGM


Environmental Health Australia (Victoria) Limited AGM will be held at 10.00am AEDST on Wednesday 14 February 2018 via teleconference.
