## Keynote Speakers

#### Dr Anne Astin PSM



Anne is a former CEO of Dairy Food Safety Victoria. She previously held a number of senior executive and management positions in the Victorian public sector for over 20 years. She has been Chair of the Australia and New Zealand Ministerial Forum of Food Regulators Implementation Sub Committee (ISC) for 4 years and was recently reappointed to this position until 2014.

In June 2011 Anne was awarded the Public Service Medal in the Victorian Division of the Queen's Birthday honours for her services to the dairy industry, national food regulation and rural women.

In March 2010 she was inducted into the Victorian Women's Honour Roll for her work in biochemistry and as an advocate of women's leadership and was the recipient of the Australia Dairy Industry Council's Outstanding Service Award in recognition of her leadership to the Australian dairy industry.

She is the first woman to have received this prestigious award.

#### Nina Bertram



Nina is a qualified Environmental Health Officer with extensive experience. She is currently employed with Byron Shire Council but previous to this role worked for Lockyer Valley Regional Council and was the EHO on duty during the January 2011 devastating floods. Nina was a member of the Local Disaster Management Group and actively evolved in responding to the flood event which caused major destruction in the Lockyer Valley area.

Nina has completed a double degree, Bachelor of Applied Science (Environmental Science) and Bachelor of Health Science (Environmental Health). She is a member of EHA and attended the EHA Disaster Management Course in Cairns in 2005 which she believes was necessary training for EHOs for responding to a flood event.
