**PROFESSIONAL DEVELOPMENT SEMINAR  
MARCH 2013**

A lively group of participants arrived at The Grange on a perfect early autumn day to participate in the enHealth workshop presented by Jamie Wood and facilitated by Kim Willing.

The workshop was one of a series of 17 being conducted across the country. The intent is for enHealth to raise awareness amongst environmental health practitioners of its available publications and resources that it has recently upgraded or developed. Considerable time, effort and money has gone into developing the well researched documents utilizing experts in their respective fields.

The documents that were discussed included -

- Arthropod Pests
- Guidance on Use of Rainwater Tanks
- Environmental Health Risk Assessment Guidelines
- Asbestos in the Home
- Local Government Environmental Health Risk Resource '*Risky Business*'

Immediate feedback from the workshop participants indicated that the sessions were most informative and not technical in nature at all. The focus was mainly on the type of information contained within the documents and how the documents could be best utilized when dealing with customers and their situations. The information contained in the documents has already been researched by experts and is now readily available for referral and use by practitioners.

It was generally agreed that more widespread referral and use of these documents would help create more consistency amongst EH practitioners and ultimately achieve better outcomes.

## FOOD FOR THOUGHT

### Third Listeria Death Linked to Australian Cheese Company

A third person has died following a listeria outbreak linked to soft cheeses produced in Victoria. Victoria's acting Chief Health Officer, Dr Michael Ackland, has confirmed the death of a 68 year old man from New South Wales in late January was linked to the listeria contamination of Jindi cheese products. An 84 year old Victorian man and a 44 year old Tasmanian man have also died of listeria infection. A pregnant NSW woman miscarried. More than 20 other cases have been reported.

Jindi has voluntarily recalled all batches of cheese manufactured up to January 6. Dr Ackland stated that the outbreak, which has been traced to the Jindi factory in Gippsland, was the largest the nation had suffered and one of the most complex. He described the process of tracking the outbreak to Jindi as an important piece of investigative work which involved obtaining food histories from victims and intelligence from OzFoodNet, as well as bacterial DNA tests to determine the strain of listeria.

The parent company for Jindi has voluntarily committed to a quality assurance program that significantly 'cranks up' its existing food safety standards and has satisfied Victoria's Chief Health Officer.

### Food Poisoning Reported at World's Best Restaurant

The Telegraph reports that 67 guests who dined at Danish restaurant Noma between 12 and 16 February 2013 became ill with food poisoning. The Australian reports that the restaurant, voted number one in the world by *Restaurant* magazine for the past three years, said that tests indicated the stomach bug norovirus was to blame. The norovirus was reportedly brought into the restaurant by a staff member. The Telegraph stated that a report by the Danish food authority investigating the food poisoning outbreak, following complaints from 63 customers, found that Noma failed to provide hot water in the taps that staff used to wash their hands and also failed to properly disinfect the kitchen before the virus had spread. The restaurant was reportedly given an official warning by the food authority and instructed to fund a follow up investigation.
